Visit to 'The Minack Theatre' (Porthcurno) Wednesday 19th June 2019

As part of our learning, we have planned for Year 3 children to visit 'The Minack Theatre' at Porthcurno to watch a performance on Wednesday 19th June 2019. Children will see an exciting theatre production of 'Ali Baba and the Forty Thieves'.

We will leave school, by coach, in the middle of the morning. Due to the timing of the performance, we will return to school at **5.00pm** (approximately). As this is a later collection time of **5.00pm**, please ensure someone is at school at this time to collect your child. If it is not person who normally collects your child, please inform us of who it will be (preferably in writing).

As the theatre is outdoors, your child needs the appropriate clothing for the weather- the performance will continue regardless. Children must wear their **school uniform** on the day. They will also need a warm, waterproof coat or sun cream and a sun hat (as appropriate). The children will be sitting on grass seating, so sending a cushion (in a bag) or a blanket may be helpful. The children will require a packed lunch and a healthy snack, which they will be able to eat once they reach Porthcurno. If your child is eligible for free school meals, we will organise a lunch for your child with the kitchen. As usual, no pocket money will be required on this trip.

A voluntary contribution of £3.00 per child to help with the costs of this visit would be very much appreciated. Should sufficient contributions not be forthcoming, we regret that the visit may not be able to take place.

NOTES
